20. # Case study: *“On 11 March 2011, the Great East Japan Earthquake and Tsunami severely damaged the Fukushima Daiichi Nuclear Power Plant (FDNPP). Large radioactivity released induced multi-hazard disasters on human livelihood and ecosystem in the Fukushima. Even today 43,000 residents of Fukushima were yet to return to their hometowns, with 33,000 of them living outside the prefecture. This is due to persistent uncertainty of long-term radiation impacts on the thyroid as well as whole body, radiation fear and anxiety having impacted some 165,000 precipitately displaced in the absence of sound risk information and communication during the initial stage of the nuclear disaster, Psychosocial and mental stresses and delayed recovery of employment opportunities and environmental livelihood”*. Based on this experience identify the role of professional social workers in addressing the key issues of the affected people in a nuclear disaster zone.
